Given the recent concerns and the precautionary measures announced by the New Brunswick government, the Beaubassin-est Rural Community will take the following measures:

The Beaubassin-est Rural Community is monitoring the situation very closely and is following directions from the Public Health Agency of Canada and the Office of the Chief Medical Officer of Health for New Brunswick. ## SITUATION SURROUNDING THE ACCESSIBILITY OF MUNICIPAL INFRASTRUCTURES

- 1- The municipal building is closed to the public until further notice.
- 2- The Fire station is closed to the public until further notice.
- 3- All non-essential activities organized by the Rural Community will be postponed until further notice.

We are in constant contact with the Emergency Measures Organization of the province and are currently in the process of reviewing the maintenance plan for the delivery of services (particularly essential services) in the event of an activation of emergency situations.

## **HEALTH INFO**

Here is some information and recommendations on personal hygiene measures to reduce the spread of COVID-19, according to the Chief Medical Officer of Health for the Province of New Brunswick.

Symptoms are similar to those of the flu; it is probably more infectious and more severe than the flu. The vast majority of cases are contracted through close contact with a sick person, the virus is transmitted by large droplets when people sneeze or from the surfaces on which the droplets are located.

## REDUCE THE POSSIBILITIES OF SPREADING

Here are the measures suggested by the Office of the Chief Medical Officer of Health for New Brunswick to reduce the possibility of spread:

- \* wash your hands as often as possible;
- \* cough and sneeze into the elbow;
- \* avoid touching your eyes, nose and mouth with your hands;
- \* stay at home if you are sick;
- \* avoid contact with a sick person;
- \* use an alcohol-based hand sanitizer if there is no water and soap.
